The Superintendent announced that it is School Board Appreciation Month. Each board member received a certificate thanking them for their support. The district's KSDE Audit is scheduled for next week. The district's KSDE Food Audit is happening this week. There will need to be a special board meeting on Monday, February 3, 2025 for the sale of the bond. The superintendent gave a special thank you to all who helped with the snow removal and cleanup. Also to Keith Kresin for helping drive the roads to ensure busses could/couldn't travel safely. He also thanked the city and county for doing such a wonderful job. The elementary school had some heating issues before the Christmas break. There was a leak in the 5th grade classroom. A circuit board at the high school burnt out because it got wet from the snow blowing up onto it. Another heating unit went out at the high school. A representative from the hospital called to inform the superintendent that they will be opening a new surgical wing and would like to add more parking. The hospital would like to add 7-10 spots to the southeast of the medical center. The hospital is willing to pay for this project. The city spoke with the superintendent and said the Hersey Street/North Walnut street project will be starting this summer. So, this will affect the driveways into/out of the high school parking lot.

Olivia Wright gave the Student Council Report.

Addie Francis gave the Jag-K Report.

There was no Site Council report.

Janet Porter gave the PTO report.

A motion was made by Krier, seconded by Adams, to approve the resolution to continue electing School Board Officers at the July board meeting. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Krier, seconded by Adams, to approve the resolution to have regular board meetings on the second Monday of the month at 6:30 PM. Motion carried: 7 Yeas, 0 Nays.

The Superintendent gave a bond update. The district has not sold the school bond yet, therefore that is not the reason residents are having an increase on their property taxes.

The board discussed the review and acceptance of bond proceeds bids. All local banks were allowed to bid. The First National Bank – Solomon Valley Bank bid 4.33% indexed to KMIP 1-89 day term. The Guaranty State Bank bid 4.055% indexed to 91-day T-bill minus 0.15%. The Security Bank of Kansas City bid 3.991% with a mix of Treasury Securities and CDs.

A motion was made by Cousland, seconded by Stillwell, to accept First National Bank – Solomon Valley Bank bid at 4.330%. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Thompson, seconded by Krier, to approve the changes and additions to the Facility Use Agreement as presented. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Stillwell, seconded by Adams, to approve the recording of all future school board meetings and posting to the school district website within five business days of the school board meeting. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Stillwell, seconded by Thompson, to approve the additions of Jr. High Assistant Wrestling coach – Marshall Musil and Jr High Assistant Track coach – Terri Engelbert to the coach list. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Krier, seconded by Ludwig, to assign Joe File, Jon Stillwell and Kelsey Adams (alternate Tony Thompson or Craig Cousland) to the Southern Cloud Cooperative Committee. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Thompson, seconded by Ludwig, that the meeting adjourn. Meeting adjourned at 8:35 P.M. Motion carried: 7 Yeas, 0 Nays.
