The Superintendent discussed district property insurance that is through Fouts Insurance. It looks as if it is going to increase 8% from last year. The district's health insurance could possibly increase up to 18.8% from last year. IMA is taking bids from other companies but so far the other bids are higher. The board tour date is set for August 8, 2025 and will begin at the elementary school, then go to the special education office, and finish at the high school. Summer projects are going well. The foundation for the new preschool building on the elementary school campus has been set. The building is scheduled to be moved from Glasco to Beloit July 15 to August 1st. The tennis courts at the special education campus will be repainted and have new nets installed this summer. The HVAC work is scheduled to start in September/October. The work at Trojan Stadium continues. The company installed perimeter turf attachment nailers, continued conduit installation, graded D-area for concrete next week.
